

WHAT YOU NEED TO KNOW ABOUT OVERDRAFTS AND OVERDRAFT FEES

An overdraft occurs when you do not have enough money in your account to cover a transaction, but we pay it anyway. We can cover your overdrafts in two different ways:

1. We have standard overdraft practices that come with your account.
2. We also offer overdraft protection plans, such as a link to another account or a line of credit, which may be less costly than our standard overdraft practices. To learn more, ask us about these plans.

This notice explains our standard overdraft practices.

➤ **What are the standard overdraft practices that come with my account?**

We do authorize and pay overdrafts for the following types of transactions:

- Checks and other transactions made using your checking account number
- Automatic bill payments

We will not authorize and pay overdrafts for the following types of transactions without your consent.

- ATM transactions
- Everyday debit card transactions

We pay overdrafts at our discretion, which means we **do not guarantee** that we will always authorize and pay any type of transaction. **If we do not authorize and pay an overdraft, your transaction will be declined.**

➤ **What fees will I be charged if First Exchange Bank of Alabama pays my overdraft?**

Under our standard overdraft practices:

- We will charge you a fee of up to \$35.00 each time we pay an overdraft if your account is overdrawn more than \$5.00
- If your account is overdrawn by \$5 or less, the Overdraft Charge is \$5.00.
- If your account is overdrawn for longer than 2 or more consecutive calendar days, we will charge your account a continuous Overdraft Fee of 2.50 for each of the consecutive calendar days the account remains overdrawn, beginning with day 2
- **There is a limit** of (\$175.00) per day on the total fees we can charge you for overdrawing your account

➤ **What if I want First Exchange Bank of Alabama to authorize and pay overdrafts on my ATM and everyday debit card transactions?**
